### **PENSIONERS' RATE CONCESSIONS**

To enable Council to allocate correct rebates to pensioners, all persons who hold a **PENSIONER CONCESSION CARD** are required to bring it to the Council Office for sighting and notation if they have not already done so. **Pension card holders are required to present cards to Council every year when new cards are issued.**

Persons not having received their pensioner rate concession or those who have only received only a 50% rate rebate **must bring their cards in to Council as soon as possible.** This will enable the correct rebates to be allocated. **Until cards are presented the rebate on rates cannot be given.** For those who cannot bring the card personally, it may be sent by mail or messenger.

**For pensioners living at Gulargambone they may take their card to the RTC where it will be copied free of charge and the copy forwarded to Council.**
