

**NOTICE OF COMPULSORY ACQUISITION OF LAND IN THE LOCAL GOVERNMENT AREA OF COONAMBLOE**

Coonamble Shire Council intends to acquire by compulsory process the land described as Lot 212 in Deposited Plan 754199, Parish of Moorambilla and County of Leichhardt, being part of the land contained in Folio Identifier 212/754199 said to be Crown Land in possession of the Coonamble Racecourse and Recreation Reserve Trust under the provisions of the *Land Acquisition (Just Terms Compensation) Act 1991* for the purposes of development of a bore bath facility.

**REMEMBRANCE DAY 2020**

Council has received advice that the NSW Government has granted a one-off exemption for Remembrance Day 2020 in allowing a maximum of 100 people to attend commemoration services around the State. It is important to ensure the service of our veterans is honoured appropriately. To ensure everyone's safety, social distancing measures must be followed and a COVID-19 Safety Plan must be in place. This exemption covers Remembrance Day Services held before 12 November.

**UPDATE ON ROADWORKS**

Council is currently completing flood damage repairs at various sections of the Merri Merri Road, Floddenfield Road and Billeroy Road. Flood damage repairs are also programmed for sections of the Kensington Road and Wingadee Road in coming weeks. Rehabilitation works on the Baradine Road are largely complete with resheeting works on the Bramble Road programmed. Council appreciates the cooperation of its residents and road users and encourages road users to drive to conditions and to adhere to the temporary traffic signage at these work sites. The programmed works are subject to prevailing weather conditions that may affect access, current harvesting conditions and truck movements and/or other unforeseen circumstances.

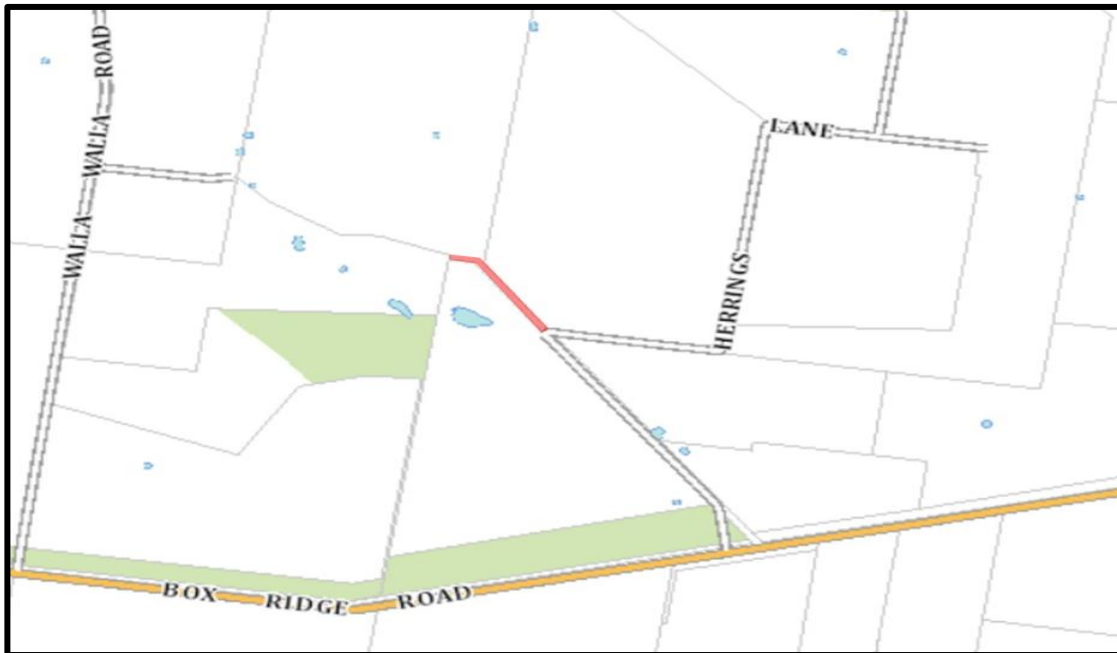
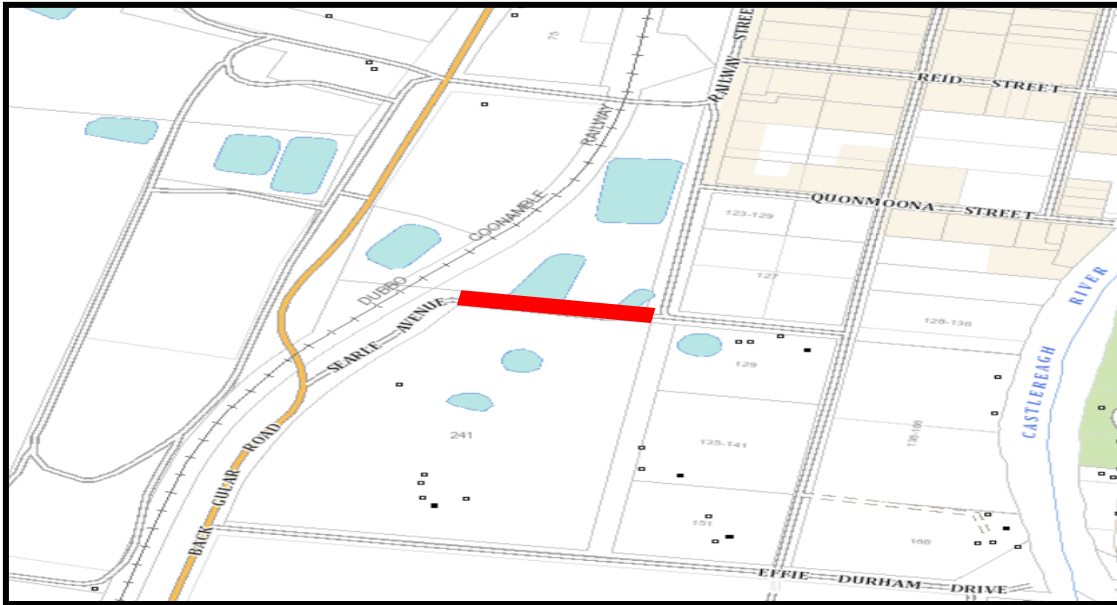
**PROPOSED ROAD CLOSING UNDER SECTION 38B ROADS ACT 1993**

In pursuance of the provisions of the *Roads Act 1993*, notice is hereby given that Coonamble Shire Council proposes to close the Council Public Roads as indicated in the accompanying maps.

- **Part Road Closure of Searle Avenue, Coonamble**
- **Northern end of Old Wongy Road (SR17b), off Box Ridge Road**

Upon closure of the road reserve, Council will categorise these roads as operational. All interested persons are invited to make submissions concerning the proposal to the General Manager, Coonamble Shire Council. Submissions will be accepted until **COB Wednesday 25 November 2020**. Once the submission period is completed, Coonamble Shire Council will consider all duly made submissions before deciding whether to continue with the road closure proposal.
